

Return-It Express “Return-It to Win-It Contest”

OFFICIAL RULES

The Return-It Express “Return-It to Win-It Contest” (the “Contest”) is offered by Encorp Pacific (Canada) (“Sponsor”) and is administered by WSP International Limited (“Contest Administrator”). The Sponsor and its direct and indirect subsidiaries, participating depots and affiliates (collectively, “Return-It Express Entities”), partners participating in the Contest from time to time (“Partners”) and other authorized third parties who may receive participants’ personal information, together hereinafter may be referred to as the “Contest Entities”.

NO PURCHASE NECESSARY TO PLAY.

General Contest Information: The Contest is being played at approximately one hundred and seventeen (117) Return-It Express Locations (“Participating Locations”) in the Canadian province of British Columbia.

Obtain three (3) Return-It to Win-It Loyalty Points (“Points”) for every qualifying beverage container returned (“Container Return”) at any Participating Location during the Contest Period (defined below), while supplies last. Limit one thousand, two hundred and sixty (1,260) Points per Return-It Express transaction. Obtain one (1) valid Return-It Express to Win-It digital scratch-off game ticket (a “Game Ticket”) for every qualifying bag of beverage containers returned (“Bag Return”) at any Participating Location during the Contest Period (defined below), while supplies last. Limit ten (10) Game Tickets per Return-It Express transaction, regardless of the number of Bags being returned. Qualifying beverage containers are those that meet the standards and specification as set out in the Return-It Express System Terms of Use (available at <https://www.return-it.ca/express/terms-5-0/>), which is incorporated herein by reference. Beer glass and beer aluminum beverage containers are not qualifying beverage containers.

You must be a Return-It Express Account Holder to earn Points or Game Tickets. If you do not have a Return-It Express Account, you can sign-up for free at <https://app.return-it.ca/register>. Follow instructions in Rule 3, How to Play, and scratch your Game Ticket to reveal Bonus Points (“Bonus Points”) that will add to your Points total. You can redeem Points for Return-It Gang Plush Characters or for entries into our Sweepstakes draws (details below). There is a maximum limit of two-hundred and fifty (250) Sweepstakes Entries per person. There is a maximum of one (1) of each of the Return-It Gang Plush Characters per person. See <https://www.return-it.ca/locations> for a list of Participating Locations.

NO PURCHASE NECESSARY: You can obtain one (1) Sweepstakes Entry without making a Bag Return by sending your Name, Email Address associated with your Return-It Express account and Phone Number clearly printed or typed on a 3” x 5” card or piece of paper to: “Return-It Express to Win-It NO PURCHASE REQUEST, c/o P.O. Box 3009, M.I.P., Markham, ON, L3R 6G4”. All no purchase requests must be received on or before August 30, 2026. There is a limit of two-hundred and fifty (250) no purchase necessary request per person. No mechanically reproduced or computer-generated requests are allowed.

1) CONTEST DATES: The Contest begins at 12:00:00 AM, Pacific Time (“PT”) on September 15, 2025 (the “Contest Start Date”) and is scheduled to end at 11:59:59 PM PT on August 30, 2026. (the “scheduled Contest End Date”) or whenever Game Ticket supplies are exhausted, whichever occurs first. The period between the Contest Start Date and the scheduled Contest End Date is known as the “Contest Period”. Certain components of the Contest will end on different dates, as indicated elsewhere in these rules (“Official Rules”).

2) WHO CAN PLAY: The Contest is open to Return-It Express Account Holders who are legal residents of the Canadian province of British Columbia and who have reached the age of 19 years as of Contest Start Date. Employees, representatives and agents of Encorp Pacific (Canada) (the “Sponsor”), WSP International Limited (the “Contest Administrator”), the Sponsor’s parents, affiliates, subsidiaries, its advertising and promotional agencies, Return-It Depot owners and staff and any

person or entity involved in the production, implementation, administration or fulfillment of the Contest, and members of the immediate family or household of any of the above, are not eligible to participate in the Contest. In these Official Rules, “immediate family” means husband or wife, mother, father, brothers, sisters, sons and daughters. There is a separate contest for Employees of Participating Locations.

3) HOW TO PLAY: Within seventy-two (72) hours of your Bag Return being counted at a participating Return-It Express location, using a registered Return-It Express account, you will receive a Game Ticket. If you have opted in for communications in your Return-It Express Account, you will receive an email notification of your Game Ticket earned. Follow the instructions in the email to open your game ticket. If you have not opted in for email communications in your Return-It Express account, you can access your Game Ticket by logging into your Return-It Express Dashboard at <https://app.return-it.ca/login> and choose Return-It to Win-It. You can also access the dashboard by visiting <https://www.returnittowinit.ca>. Once you have accessed your Game Ticket, follow the instructions to use your mouse or finger to ‘scratch’ the ticket to reveal the game message. For Personal Return-It Express accounts, every Game Ticket will reveal between five (5) and fifty (50) Bonus Points. For Business Return-It Express accounts, every game ticket will reveal between five (5) and twenty-five (25) Bonus Points. See table 1 below for Bonus Point Denomination odds. **All Game Tickets must be opened by 11:59:59 PM PT on September 8, 2026.**

4) HOW TO REDEEM: Access the contest website by logging into your Return-It Express Dashboard at <https://app.return-it.ca/login> and choose Return-It to Win-It. Then Choose REDEEM POINTS. You will see your total Points balance and your redemption options. Use your Points to redeem for Sweepstakes Entries or for Return-It Gang Plush Characters. Your totals Points must be equal or greater than the Points required for each redemption option. See Table 3 below for Points required to

redeem. **All Points must be redeemed by 11:59:59 PM PT on September 8, 2026.** To “redeem” means to use the points in exchange for Return-It Gang Plush Characters or Sweepstakes Entries. The points have no cash value and are not exchangeable. The points cannot be assigned, purchased, or gifted. The points cannot be sold, traded, bartered, rented, or otherwise disposed of. The points are void if sold for cash or any other consideration. Each Return-It Express Personal Account Holder is entitled to only one full set of eight different Return-It Gang Plush Characters. If more than one Return-It Express Personal Account Holder identifies the same household mailing address in the account profile, the Return-It Express Personal Account Holders together, and not separately, will be entitled to only one full set of eight different Return-It Gang Plush Characters.

* There is a maximum limit of two-hundred (250) Sweepstakes Entries per person. Number of available Return-It Gang Plush Characters will decrease as redeemed and are available while supplies last. Once an individual character is out of stock, it will be unavailable for redemption. In the event a chosen Return-It Gang Plush Character that has been redeemed is no longer available, the Sponsor reserves the right to substitute the chosen Return-It Gang Plush Character with an available Return-It Gang Plush Character.

5) SWEEPSTAKES PRIZES: There are a total of twelve (12) prizes available to be won. All winners will be randomly selected for each prize drawing from among all eligible Sweepstakes Entries redeemed prior to the date of each drawing. All non-winning Sweepstakes Entries will automatically roll over into any subsequent drawing(s). All drawings will be conducted at the Administrator’s offices in Markham, Ontario at 2:00pm EST, on the drawing dates shown in Table 4 below. Winners must correctly answer the mathematical skill-testing question on the Release Form. The following prizes are available to be won:

Additional Details on Prizes:

\$10,000 Prize: The prize will be paid by cheque for \$10,000.00 payable to the winner.

\$1,000 Prize: The prize will be paid by cheque for \$1,000.00 payable to the winner.

Odds of winning a Prize are dependent upon the number of eligible entries received throughout the Contest Period.

All Prizes are non-transferable and no cash redemption or other substitution, in part or whole, is allowed except by Sponsor who may substitute a prize of equal or greater value should the advertised prize become unavailable. No compensation is offered for any portion of the prize not utilized; any portion of the prize not utilized, and its corresponding value will be forfeited.

6) NOTIFICATION AND REDEMPTION:

For \$10,000 and \$1,000 Prizes: If you have been selected as a potential winner of a Prize Draw as described above, the Sponsor or Contest Administrator will notify you via email, postal mail, or phone. A minimum of three (3) attempts will be made to contact the selected entrant to arrange for redemption of the prize. Prizes that are not claimed after the third attempt to be contacted will be deemed forfeited and a new winner will be drawn. As a condition of awarding the Grand Prize, selected entrant must sign and return, within seven (7) days of receipt, the Sponsor's Release Form confirming his/her compliance with these Official Rules and releasing the Sponsor, any Prize suppliers, their respective administrators, affiliates, subsidiaries, advertising and promotional agencies, and the directors, officers, partners, dealers, employees and agents of each of the foregoing, from and against any and all liability arising from or in connection with participation in the Contest or the acceptance, possession or use/misuse of any prize. Before being declared winners, all selected entrants will be required to correctly answer, unaided, a mathematical skill-testing question administered by the Sponsor or Contest Administrator. If a potential winner fails to return the required documents in accordance with these Official Rules or is found to have violated the rules of the Contest in any way, or if any prize or prize notification from Sponsor is returned as undeliverable, the potential

winner will be disqualified and will be deemed to have forfeited the prize in question. Sponsor will conduct a random draw to select an alternate prize winner.

For Return-It Gang Plush Characters Redemption: After redeeming for a Return-It Gang Plush Character as outlined above, you will be asked to confirm your mailing address. Your Return-It Gang Plush Character will be shipped to your address by regular mail to mailing address provided (British Columbia only). The person redeeming is responsible for ensuring that their mailing address identified is current and correct. If the mailing address is incorrect, the Sponsor is not responsible for any replacement shipments. In addition, the Sponsor will not ship Return-It Gang Plush Characters to a mail address outside of British Columbia.

7) ODDS: Odds of winning a Prize depend on the total number of Sweepstakes Entries redeemed for and available prior to each prize drawing.

8) PUBLICITY: Acceptance of a prize or completing the electronic Online Release Form constitutes permission for Sponsor to use any winner's name, likeness, voice and/or comments for advertising, trade or promotional purposes worldwide in commerce and in any media without limitation or additional compensation unless prohibited by law. Each participant hereby represents and warrants that he/she has the right to provide the submitted personal information.

10) RESTRICTIONS: The following are prohibited and will result in automatic disqualification from the Contest: (1) using any method that artificially increases odds of winning; (2) non-compliance with these Official Rules; and (3) any other act which the Sponsor determines in its sole discretion, jeopardizes the integrity or proper conduct of the Contest.

However, the Sponsor reserves the right to close Return-It Express Personal Account(s) without notice if Return-It Express Personal Account(s) has not been used for one year. A Return-It Express Personal Account Holder may contact the Sponsor to request the reinstatement of a closed Return-It Express Personal Account. The Sponsor is not responsible for verifying the actual identity or authority of a user of any login name or password.

Return-It Gang Plush Characters Warranties: The Return-It Gang Plush Characters are being awarded "as is" with no warranty. To the maximum extent permitted by law, the Promotion Entities disclaim all representations and warranties, express or implied, with respect to the Plush Promotion, including, but not limited to, implied warranties of any merchandise, or the merchantability, fitness for any particular purpose of the Return-It Gang Plush Characters.
